Terms and Conditions of Trade

1. Definitions

- "We", "Us", "Our" refers to Zaptek Electrical Limited, the electrical services provider.
- "You", "Your" refers to the customer engaging our services.
- "Services" means all electrical work, supply of materials, consultation, and other related services provided by us.
- "Quote" or "Estimate" refers to the price provided to you for requested work, subject to change based on final scope.

2. Acceptance of Terms

 By engaging our services, accepting a quote, paying a deposit, or allowing work to proceed, you agree to be bound by these Terms and Conditions.

3. Scope of Work

- Work will be carried out as described in our quote or as otherwise agreed in writing.
- Any variations or additional work must be approved and may incur additional charges.

4. Variations

- Any changes to the original scope of work, including customer requests or unforeseen site conditions, are considered variations.
- Variations must be agreed to in writing (email or signed variation form) before the additional work proceeds.
- Variations may affect the project cost and/or completion timeline. You will be notified of any such impact before work continues.
- We reserve the right to suspend work until variation agreements are confirmed.

5. Pricing and Payment

- All prices are in New Zealand Dollars (NZD) and exclusive of GST unless stated otherwise.
- Payment is due within 7 days from the date of invoice unless otherwise agreed in writing.
- Late payments may incur interest at 1.5% per week and debt recovery costs.

6. Deposits

- For projects estimated at over \$2000, a deposit of 25% of the total quoted amount is required before work begins.
- Deposits secure your booking and allow for the ordering of materials.
- Deposits are non-refundable unless otherwise agreed, except where required by law.



7. Call-Out Fees

- A standard call-out fee of \$145 + GST applies for on-site visits, including fault finding/diagnostics and minor repairs.
- After-hours, weekends, or emergency call-outs may incur higher fees, which will be disclosed at the time of booking.
- The call-out fee is payable regardless of whether any further work is carried out.

8. Consumer Guarantees Act 1993

- If you are acquiring our services for personal or household use, you are protected under the CGA.
- If you are acquiring services for business purposes, you agree that the CGA does not apply (as allowed under the Act).

9. Warranties and Guarantees

- All work will comply with the Electricity (Safety) Regulations 2010 and applicable NZ standards.
- Workmanship is guaranteed for 12 months from the completion date.
- Product warranties apply as provided by the manufacturer.

10. Access and Safety

- You must provide safe and clear access to the worksite.
- We reserve the right to delay or refuse service if conditions are deemed unsafe.

11. Delays and Force Majeure

 We are not liable for delays caused by weather, supplier issues, illness, or any event outside our control.

12. Liability

- Our liability is limited to the value of the services provided or as required by law.
- We are not responsible for indirect or consequential losses.

13. Cancellation

- A cancellation fee may apply if scheduled work is cancelled with less than 24 hours' notice.
- For projects requiring a deposit, you may forfeit the deposit if the work is cancelled after materials are ordered or time is allocated.

14. Dispute Resolution

- We aim to resolve any concerns fairly and quickly. Please contact us first with any issues.
- If a resolution cannot be reached, both parties agree to mediation before initiating legal proceedings.
- Legal action must be pursued in a New Zealand court.
